Geoff Matcham who lived on The Hard wrote his first letters of complaint in 1984 regarding surface water and then in 2009 about the sea defences. He doggedly continued with his campaigns until his untimely death in 2010. Ever since, ESL Ltd has done all in its power to alleviate the problems and push ahead with the campaigns, with many hours of input from our dedicated voluntary group right up to the present day. We never gave up. Southern Water completed works to the foul water system a few years ago and now West Sussex County Council are delivering us an improved surface water system. The Environment Agency is scheduled to start significant beach defence work this autumn.

I shall personally be raising a glass to Geoff and to all the volunteers who have since been involved in achieving what at times we thought would be impossible. Well done to us all!!

Sea Defence Works

The Environment Agency (EA)
continues to prepare detailed
plans for these works which
are designed to remove the
risk of flooding from the sea for
much of the estate for the next
50 years. The logistics plan
has been prepared and work
constructing the extended sea
defence is now expected to
start on 1 September and be
completed before Christmas.

These works will not come
through the estate but will be
carried out with access by
machinery along the beach
from the east, rock will be
delivered from Cornwall being
brought in from the sea on
barges, and shingle will be
dredged from a bank off the
Worthing coast also delivered
by sea. A slipway is to be
constructed as part of the
works to provide access for the
boat yard passing over the new
rock revetment and down to
the beach. This project costing
in excess of £5 million has
been secured from the EA with
a contribution of £25,000 from
ESL, and a further small
contribution by Arun DC.

Surface Water System

West Sussex County Council
are currently delivering the
improved system to remove
surface water from the estate
at no cost to the estate, using a
grant of £240,000 secured
from the Environment Agency.
This will reduce the impact of
sudden rainfall which creates
surface flooding, June 2012
being an example of a
particularly severe event. This
involves installing new larger
diameter pipe work and gullies
in roads, complete new runs of
drains for example at the
Manor Way entrance, and a re-
profiling of the Elmer ditch to
re-establish the route for
surface water to the sea. It is
recognised that these works
which will take perhaps six
months to complete, will cause
significant disruption, however,
they will deliver significant
benefits for the estate.
Problems may arise, such as
breaking the odd water pipe,
messy roads, verges and the
playing field, for a period of
time so members grinning and
bearing the pain for a while is

much appreciated. That said ESL continues to discuss issues with the contractor as they arise.

Emergency Resilience Training Courses

A number of residents from the estate have attended workshops arranged by the MOSPC resilience group, to discuss procedures, plans and resources that could be made available in the event of an emergency. This linkage has been extended further to join up surrounding parish councils. These improved links will make volunteer resources available to join together and bring action to help address any emergency that arises in the area, for example the severe flooding that occurred in 2012.

The reason for putting together this programme is to be able to provide the emergency services with local knowledge and, in particular, to provide assistance for vulnerable members of our community. Whilst we tend to think 'vulnerable'/'elderly', there are others that may need help during an emergency – e.g.:

- Families with young children
- People with medical needs (daily visits from a health professional) (life-saving medication/equipment)
- Someone living alone

As part of this initiative WSCC have provided a number of items for use in an emergency.



The estate has its own emergency plan and team of volunteers. This team will meet together in a few months time to discuss and test our plan. Any additional volunteers to join the team, to be called upon to help in the event of an emergency, will be very welcome.

The ESL Council is made up of volunteer ESL members elected at the Annual General Meeting. The Council makes decisions on running the estate based upon what it believes the majority of members want, however it is recognised that with such wide spread opinion identifying a common outcome that satisfies everybody is impossible. It is not unusual for some members to be upset by decisions taken. Additionally, many see the Company Secretary as being ESL, as that is the normal point of contact with the company. The Secretary acts on

instructions from the Council, serving on a part time basis, and deserves downtime especially when out on personal social occasions. Regrettably, the number of occasions when the Secretary and Directors receive abuse whilst attempting to carry out their responsibilities increases. In order to take an up to date view on members' opinions, a questionnaire has been issued with the annual report papers. It is hoped that it will be returned from most of the 380 member properties on the estate, with further comments on additional paper if required, so that the council has up to date opinions to aid decision making. It is not just the extremes of opinion that are requested but preferably replies from all member properties.
