Sorry this newsletter is a bit later than normal; I held it back because I wanted to include the latest information about Elmer Sands Beach Defences which follows.

Elmer Sands Beach Defence Improvements

The Environment Agency (EA) had allocated funding complete this project to before March 2016, primarily extending the rock island in front of the boat yard. The EA were contributing £475,000 and ESL £25,000. However we found out recently that the EA had changed their plans.

Whilst the same money is apparently still available and works are still expected to be delivered before March 2016 the EA are now considering different а solution which currently does not include modifying the rock islands.

ESL and a few residents met with the EA on 13th November when thev explained that a new plan during will be prepared December which we should get to see early in the New Year.

The Environment Agency has apologised and promises to get things moving as soon as possible.

Further Projects to reduce the probability of flooding in Elmer Sands

1. SWMP Plan £240,000 (Surface Water Management)

West Sussex County Council (WSCC) has engaged consultants (CH2M Hill) to propose how best to spend this funding to deliver optimum improvements, to reduce the chance of surface water flooding. This arises during periods of heavy rain when the surface water cannot be cleared quickly from the Estate. ESL has met with both parties to hiahliaht the significant concerns and to focus their considerations. CH2M Hill is to report back in the next few months so that clear proposals can be delivered early in 2016.

2. Ditch - Ancton Way / Kingsmead Road £16,680

It was reported in the Middleton News that there funds were no made available bv WSCC Operation Watershed for projects submitted by the Elmer & Middleton Strategic Action Group or the Middleton Council. However we are pleased to report that ESL were in fact successful application in their for £13,000 towards the ditch work carried out at the western end of the estate between Ancton Way and Kingsmead Road. This work was to re-establish the historic flow of surface water from the ditch at the rear of The Layne out to the farm land ditches north of our further However estate. work is being investigated by WSCC and Arun District Council (ADC) to clear the the ditch at rear of Sunnymead Close where the ditch still does not operate as it should.

3. South West Sussex Internal Drainage District (SWSIDD) - Abolition

The EA undertake maintenance of the ditch to east of the estate the between The Hard and the fields (Elmer Ditch also known as Ryebank Rife) under the provisions of the SWSIDD however there are proposals to abolish this bodv. The ΕA also maintained the ditch running

between Sea Way and Elmer Close (Elmer Sands Estate Ditch). The EA have recently posted letters to properties backing onto these ditches advising that they may be affected by this abolition.

ESL has obtained confirmation from the EA that as they classify the Elmer Ditch (Ryebank Ditch) as a main river they will continue to maintain it. ESL is investigating who will have responsibility for maintenance of the Elmer Sands Estate Ditch if the SWSIDD is abolished.

We have several bins located through the Estate which are emptied daily by the local authority. Owners are allowed to dispose of dog waste in normal bins providing it is bagged, so there is no excuse not to pick up your dog waste from the beach, roads and verges and take it home with you if there is no dog bin close by. Please help to keep our Estate clean and healthy.



Winter Verge Damage – The verges

will be softer and wetter during the winter so please take care not to park on them and/or damage them because this compromises the surface water drainage soak away system and looks unsightly. It is the responsibility of the homeowner/occupier to repair any damage caused by activity at a property.

Polite Notice

As part of our careful woodland management, we are undertaking some new tree planting.

Most of the trees here were planted at the same time in the 1930's and have all reached the same state of maturity at the same time, this has made them vulnerable to storm, vandalism and disease damage.

We will shortly be planting the next generation of trees around the perimeter of the woodland, in order to sustain it for our future generations.

We have experienced problems in recent years with some people cutting down smaller trees and removing them, this jeopardizes the long term health of this woodland; we will be installing some fencing to protect the newly planted young trees whilst they establish.

The fencing will not interfere with the permissive use of our Private Woodland; we welcome responsible walkers and dog owners to enjoy these woodlands.

If you witness anti-social behaviour such as people filling in ditches, creating earth mounds, damaging tree bark or lighting fires, please either report it to the Police or to me; it would be greatly appreciated for all of us who enjoy care for these woods.
