New Council Sub-committees and Working Groups - (see separate list).

**Roads** – Full schedule of repairs identified. Tenders for consideration September Council Meeting.

**Sea Defences** – Meeting of the new sub-committee for handover briefing and follow up actions with Environment Agency (EA).

**Surface Water Drainage and Flood Prevention** – New sub-committee forging links with Arun District Council (ADC), West Sussex County Council (WSCC), residents and volunteers. Waterway inspections and annual jetting of Estate drains on schedule.

**Flood Watch** – Resident Linda Smith collecting data. See separate notice.

**Sea Pollution (Southern Water Sewage)** – ESL representation, links with campaign groups and agencies.

**Security Guarding** – Guard welfare sunshade purchased. Additional 'On Duty' Invictus signage ordered. Guard shifts arranged for the summer (see separate notice).

**Parking Management** – Additional volunteer directors to expand the existing parking monitoring team. Additional OPS signage installed in problem areas. Summer focus will be on unauthorised beach parking (see separate notice).

**Property Development inc. Access Alterations** – ongoing monitoring and engagement with owners/developers, ESL 'Development' agreement and site requirement compliance. Access Licence applications and assessments. Related matters surface water drainage, parking.

**Verges** – Continued monitoring of Estate verges, engagement with homeowners for action and ESL assistance with problem areas.

**Community Service** – ESL collaboration with WSCC to arrange supervised volunteers (one-to-one) for maintenance tasks on the Estate including painting the Kiosk fence and bollards.

**Footpath to rear of Boat Yard** – WSCC cutting once per year at ground level. ESL and householders responsible for overhanging growth. Andrew clearing for ESL as required.

**Coastal Footpath** – Clearance of overgrowth on narrow pathway.

**Jet Ski Launching Ban** – Distribution of ESL Policy as applicable. No launching from ESL land.

**Holiday Letting** – Ongoing monitoring, engagement with property owners, ESL focus on good practice and residents' complaints procedure.

**Sun Deck (rear of Kiosk)** – ESL taking steps to prevent public urination in this area.

**Children's Playground** – Road safety signage purchased. Playground inspection booked, inc. damaged equipment and bark depth assessment.

**Stable Field Yard Lease** – On-site meeting with tenant. Lease compliance maintenance tasks underway. Engagement with neighbouring properties.

**Elmer Sands Boating and Angling Club (ESBAC)** – Inspection of premises scheduled. ESL/ESBAC liaison for membership updates and Lease compliance. Discussions to collaborate on social events.

**Community Social Events** – Postponed Coronation event on the field with live music enjoyed by members and their families. Thanks to all volunteers, more always welcome!
